PURPOSE:

The purpose of this document is to amend the By-Laws to allow the sale of the recreation facilities to an individual or individuals.

RECITALS:

Coronado Woods Association members were properly notified of a meeting to be held June 15, 1992, for the purpose of voting on an amendment to the Ry-Laws permitting the sale of all or part of the recreation facilities to an individual or individuals. Such meeting was held with over 75% of the membership voting in favor of the amendment.

Article IV

PROPERTY RIGHTS:

Section 1. EASEMENT OF ENJOYMENT; LIMITATIONS

The right of the Association to dedicate or transfer all or any part of ß. the recreation facilities to any public agency, authority, or utility for such purposes and subject to such conditions as may be agreed to by the Unit owners.

Such dedication or transfer shall be effective if an instrument signed by Unit owners constituting seventy-five percent (75%) of the voting power of Unit owners agreeing to such dedication or transfer has been recorded:

AMENDMENT:

THE RIGHT OF THE ASSOCIATION to dedicate or transfer all of any part of the recreation facilities to any public agency, authority, utility, individual or individuals for such purposes and subject to such conditions as may be agreed to by the Unit owners. Such dedication or transfer shall be effective if an Instrument signed by Unit owners constituting Seventy-five percent (75%) of the voting power of Unit owners agreeing to such dedication or transfer has been recorded.
